- 3. **Credit Checks.** We will run a few checks on the information you have provided us using both public credit score systems and in-house records. The final credit amount approved is based on several factors such as the volume of spending, recommended by a third-party credit system and approved by our credit team. If all checks are passed, a new account will be created. We will provide you with the following information:
 - a. Unique Account Number
 - b. Credit amount
 - c. Crest Medical Bank Details

Please note, as an alternative to the Credit Check process mentioned above, we will honour any existing payment terms you have with CD Medical Ltd. If you wish to keep those payment terms instead of starting from fresh, please indicate so when contacting us. Our standard payment term is '30 days end of the month' (i.e., payment is due 30 days after the end of the month in which you receive the invoice).
